



## Prospectus for Online Juried Exhibition

### SUBMISSIONS

- All artists 18+ are encouraged to submit for our current online exhibition, scheduled to open November 26, 2007. All submissions will be posted for an extended period of time, November 28 – January 18, 2008, within our gallery, offering exposure and promotion of your work to a variety of art professionals. All submissions will also be viewable in our Exhibition Archive for one additional month.
- All mediums accepted. Sorry, no sound or video at this time.

### AWARD

- All participants will qualify and participate in the open jury process. Jury process will be held from November 26 –December 8, 2007.
- 10 Semi-Finalists will be selected by public jury and will be posted as such. Semi-Finalists will be posted on December 9, 2007 and will be displayed from December 9 – December 15, 2007 in the Semi-Finalist's gallery.
- Semi-Finalist receiving highest rating will be awarded "Best in Show" and will be announced on December 19, 2007.
- "Best in Show" artist will receive a cash award determined on the basis of entries received, with a minimum award of \$200.00 USD. "Best in Show" artist will also be featured on the front page of the Emerging Artists Group site and submissions displayed December 19 – January 28, 2008.
- "Best in Show" Artist will be notified on December 19, 2007 via email.

### JURORS

- This exhibition will be publicly juried. Galleries, collectors, curators, designers and various art professionals, as well as the general public, are invited to participate in the jury process. At this time, they will have the opportunity to view the work of all submissions and submit their choice for "Best in Show" as well as the ability to contact any of the artists regarding purchase, representation, or to leave comments. All Artists and Visitors to the Emerging Artists Group site will also have the opportunity to act as jurors, contact artists and leave comments.

### DEADLINE

- Submissions for the December 2007 Exhibition must be received from **October 19 – November 18 2007** midnight (PST).

- Submissions may be sent via email or standard mail.
- Please complete online or printable application.
- Email submissions should be sent as jpegs.
- Standard Mail submissions (**Slides, CD'S, Photographs, Reproductions (8"x10")**)
- If you would like your images returned, please include a SASE.
- Clearly label back of image with your name, title of work, medium and dimensions.
- An arrow can be used to indicate the top. You may also include an artist's statement typed or on CD (200 word. max.)
- Submissions received after the deadline will be include in our next bi-monthly exhibit.
- Not responsible for lost or damaged entries.
